Sir/Madam,

I am directed to say that on the basis of the result of Stenographer Grade 'C' and 'D' Examination, 2020 conducted by the Staff Selection Commission, you have been nominated for the post of Stenographer Grade 'D' in Central Passport Organisation and are hereby offered an appointment to the aforesaid post on temporary basis in the Central Passport Organization (a subordinate organization under the Ministry of External Affairs, Govt. of India) with initial posting at **Passport Office, Madurai**. The scale of the pay of the post of Stenographer Grade 'D' is in the level-4 (Rs. 25,500- 81,100) of Pay Matrix given in Seventh Pay Commission plus usual allowances at the rate admissible and subject to the conditions laid down in the rules and orders governing the grant of such allowances in force from time to time. Your initial pay will be fixed in this scale in accordance with the extant rules.


2. Your appointment to the post shall be subject to the following terms and conditions:-

(i) Your appointment is provisional and subject to verification of your character and antecedents from the concerned authorities as per procedure laid and your medical fitness by a Medical Officer not below the rank of Civil Surgeon. If you are already employed in an office under the Central Government or of a State Government and have been previously medically examined by Medical Officer of the rank of the Civil Surgeon and declared fit for appointment, you can be exempted from the requirement of fresh medical examination provided a certificate of previous satisfactory medical examination is forthcoming from your office.

(ii) You will be on probation for a period of two years from the date of your joining, but the period of probation may be extended if the appointing authority considers it necessary.
